

### 1. Global Activities:

### 1.1 College of Presidents:

With the aim of profiting from the previous experience and wisdom of the past-presidents of IASP and also in order to keep involved as much as possible key-people in the life of our association, a "college" of presidents is proposed. This institution should act as a privileged consultant to the executive board of IASP, after appointing a spoke-person.

### 1.2 Table of Main Organisations:

T o

bring together the main organisations in the field of suicide prevention in order to harmonise planned and ongoing activities of the several existing organisations; exploratory investigation should be made with regard to the feasibility of a meeting amongst the delegates of each major association. Time and location for this initiative could be coincident with major suicidological events.

### 1.3 World Suicide Prevention Day:

Initiate and launch the World Day for Suicide Prevention in September 2003 at the IASP Congress in Sweden.

### 2. Council of National Representatives:

To meet the constitutional requirements of the Association which provides for the widest membership representations and therefore open dialogue and the availability of knowledge, skills and experience in combating suicide world-wide.

### 3. Council of International Organisations:

To meet the constitutional requirements of the Association which provides for organisational membership representations by encouraging more dynamic relationship and interaction within the overall membership in order to encourage the development of dynamic programmes and research in suicide prevention.

### 4. Projects/Programmes:

### 4.1 Awards

Provision of awards to honour the contribution of individuals in the field of suicide prevention. The three awards are: The Stengel Research Award, Ringel Service Award and The Farberow Award.

**4.2** Latin Section of IASP.

Establish a sub group of IASP communicating in French and Spanish in response to membership requirements.

- **4.3** Volunteer Agency Survey of all the volunteer-resourced suicide prevention services throughout the world in order to understand the complexity and magnitude of the volunteer resource working in suicide prevention activities.
- **4.4** Directory of Survivors of Suicide providing detailed information to survivors, health and mental health professionals, and the general public of the availability of such services to assist in the difficulties of bereavement and mourning a suicide entails.

### 5. Organisational Development:

- 5.1 IASP Constitutional Matters
- Establishing charitable status in Norway, Switzerland and USA.
- Reviewing the constitutional status of IASP to ensure it is relevant to society today, worldwide.
- Activate Board development and prepare for succession.
- Develop policies and procedures.
- **5.2** Resource Development: funds, membership and contributors (recruitment strategy, sponsorship programme and fundraising).

### IASP Awards 2003 - Nominations

The International Association for Suicide Prevention (IASP) provides awards for those who have contributed in a significant way to the furthering of the aims of the Association. Awards are presented at the IASP biennial conference.

**The Stengel Research Award** has been provided since 1977 and is named in honour of the late Professor Erwin Stengel, one of the founders of IASP. This award is for outstanding research in the field of suicidology, and nominations can be made by any member of IASP.

**The Ringel Service Award** was instituted in 1995 and honours the late Professor Erwin Ringel, the founding President of the Association. This award is for distinguished service in the field of suicidology, and nominations can be made by National Representatives of IASP.

**The Farberow Award** was introduced in 1997 in recognition of Professor Norman Farberow, a founding member and driving force behind IASP. This award is for a person who has contributed significantly in the field of work with survivors of suicide, and nominations can be made by any member of IASP.

### THE STENGEL RESEARCH AWARD

Members of the International Association for Suicide Prevention (IASP) are invited to nominate suitable persons for the Stengel Research Award. Nominees do not necessarily have to be IASP members. The criteria for selection are:

- outstanding and active researcher with at least 10 years of scientific activity in the field, as evidenced by a number of publications in internationally acknowledged journals;
- national leadership in the area;
- □ suicidology is main (focal) area of interest/work;
- □ author/co-author of at least one international book;
- reasonable expectation (outline to be submitted) of further research activity in the field.

1	Task Force on Guidelines for the Development of Suicide Prevention Agencies
	(established March 1994).

Aims	
	To describe the different sectors to be considered when preparing suicide guidelines (e.g. ethics, organisation, education, cooperation, evaluation);
	To define the essentials given these different sectors;
	To describe different types of suicide prevention agencies and their different needs;
	To collect samples of agencies from different countries in respect of how they have filled the different essentials mentioned above.
Strate	egies:
	Consultation of experts for special questions.
	Collection of different types of agencies all over the world by intensive contact with national representatives of IASP, specific members and institutions.
	Elaboration of a frame for guidelines, to be specified individually for different types of agencies and in different regions of the world.
	Publication of a Survey of Voluntary Agencies in Suicide Prevention.
2	Task Force on Survivors of Suicide (established September 2000).
Aims	
	To identify and compile a list of bereavement services offered in each country for survivors of a suicide by a loved one.
	To increase IASP's involvement with this important group.
	To increase awareness and further understanding of the needs of this group by the public, by

	First survey will focus on European and Australian/New Zealand areas, where some activities already exist.
	After information is received a directory will be published and made available to relevant office agencies and persons.

### Task Forces: work in action

#### Aims:

The aim of this Task Force is to formulate prevention and intervention strategies to discourage suicidal terrorism.

### Strategies:

- □ Collect available data about suicidal terrorist acts.
- □ Study the processes that lead to suicidal acts of terrorism.
- Formulate profiles of suicidal terrorists.
- □ Formulate the most relevant theories or explanations of the aetiology of suicidal acts of terrorism.
- □ Study the role of pressure and education of potential suicidal terrorists by terrorist organizations as well as religious and peer influence.
- □ Study the media influences in reinforcing suicidal terrorism.

### 5 Task Force On Genetic Aspect Of Suicide Ideation And Behaviour

The task force will consist of a working group of three IASP members already active in this field. The Working group will liase with all other experts from within IASP and will establish continuous communication with outside organisations and their experts in the field of psychiatric and behavioural genetics.

#### Aim:

The main aim of the Task Force will be to examine suicide ideation and behaviour as an interplay of genes and environment (the so called genome-environment interaction).

### Strategies:

- □ Systematically review current knowledge in the field of suicidology genetics.
- Rethink possible new research strategies in suicidology. It is a view that populational and molecular genetic research is an obvious next move, since this may allow targeting of psychosocial or pharmacotherapeutic interventions at persons and population of high suicide risk.
- □ Establish contacts with associations and organisations in the field of psychiatric and behavioural genetics and invite their members interested in suicidology to join IASP. For example, the president of the World Association of Psychiatric Genetics has already published his paper in the most recent issue of Crisis.
- Organise regular meetings of experts in the suicidology genetics also as part of future world IASP congresses.
- Explain suicide ideation and behaviour as an interplay of genes and environment. At the same time, discourage some misconceptions about genetics, e.g. that genetic is only biological (e.g. the risk of marital problems and divorce is partially under genetic control) and that environment is only psychosocial (e.g. the environment appears to exert its biological influence even in the perinatal period, and thus affecting the ability to deal with stressors at a later age).
- Examine the most likely reactions of the community including the media to new hypotheses and theories of suicide behaviour as an interplay of genes and environment. Accordingly, suggest the most appropriate dissemination of results in the field.
- On the basis of the above suggest suicide prevention and intervention strategies: personal and populational levels.

All Task Forces will have the opportunity to submit an interim report at the IASP Congress in Stockholm, Sweden in September 2003.

### 6 Task Force on Identifying Mechanisms Underlying Falling Youth Suicide Rates

### Workgroup Goals:

- I Develop common protocols to gather data across and within countries.
  - 1 Document change in adolescent rates across informative member countries.
  - 2. Document change within countries to note differences in the rate change in different ethnic SES, and urban/rural groups.
  - 3. Where data is available, track the change in rates among adolescents across time and within country against:
    - a. Appropriate local alcohol/substance use rates.
    - Significant changes in adolescent health policies, mental health resources and entitlements.
    - c. Changes in psychoactive medication prescription rates for adolescents.
    - d. Autopsy toxicology findings in adolescents who have suicided.
- II Seek collaboration/participation /analytic assistance from WHO, CDC and various governmental agencies for the above.
- III Seek funding for one or more face-to-face meetings and to cover other communication costs.
- IV Depending on preliminary findings, promote the funding of a naturalistic multi-site prospective, but open and uncontrolled study on a large representative sample of teen attempters/depressives to examine outcome correlates of different forms of management.

### USA: Annual meeting in Sante Fe, Mexico

Located between the high desert and the high mountains, Santa Fe, New Mexico is the oldest state capital in the United States and the site of the 36<sup>th</sup> Annual Conference of the American Association of Suicidology, April 23-26, 2003. Infused with the heritage of the desert Southwest, the traditions and beliefs of Pueblo Indians and Hispanic cultures, Santa Fe is also home to hundreds of artisans and the finest of cuisine. In this community, more than 700 are expected to attend the AAS conference which will feature close to 200 papers, panels, poster presentations, and workshops.

Featured speakers at this year's conference will focus on the latest in research on cognitive behavioural treatments, the relationship between alcoholism and suicide, and the role of culture in understanding suicide. Research hypotheses to explain recently observed decreases in suicide rates, both in the States and internationally, will be discussed and debated by IASP members David Shaffer, David Rudd, Lanny Berman, and Bob Goldney. Recent successes in preventing suicide in the U. S. Air Force will be extrapolated to the non-military community. Other presentations will range across a broad array of topics from best practices in suicide prevention and prevention program evaluation models, to impulsivity and suicide, help-seeking behaviours among males, ethical issues in suicide research, and youth suicide risk factors. Included in this year's program are a large number of half and full-day workshops intended to offer intensive training on subjects ranging from interview skills, to managing and treating self-injurious patients, treating dual diagnosis patients, and dealing with depression and suicide in the medically and terminally ill.

Special events are planned including annual golf and tennis tournaments as well as sightseeing opportunities throughout the region.

### IASP: Elections 2003

Ballot papers for the election of an Executive Committee 2003 are now being prepared. A call for nominations has been made and all fully paid up members of the Association are requested to select future members of the Board.

Key dates are 15 April all nominations to be received by the Election Committee;

20 August all ballot papers received by the Election Committee;

13 September announcement of results in the General Assembly, Stockholm, Sweden.

The Executive Committee composes a President, a General Secretary, a Treasurer, three Vice-Presidents, the chairperson of the Council of National Representatives, and the chairperson of the Council of Organizational Representatives. The terms of office extend from one General Assembly to the next.

A member may be in the same position for two terms (ie. 2 years plus 2 years) and then can only be re-elected for one further period of 2 years in a different board position.

Please note therefore that the current Executive Committee have been in position for:

- calling the General Assembly, the Council of National Representatives, and the Council of Organizational Representatives into regular session;
- appointment of scientific, technical, and administrative bodies;
- decision over applications for membership;
- □ decision on expulsion and/or suspension of members;
- for all financial matters;
- maintaining full records of all meetings;
- engage in those activities which further the goals of IASP, and drawing up of its own order of business within the framework of the Constitution.

- discharges all duties assigned by the General Assembly, the Council of National Representatives, the Council of Organizational Representatives, and the Executive Committee;
- provides regular presentations of administrative reports to the Executive Committee and to the members;
- maintains the archives of the Association.

### The Treasurer:

In accordance to the IASP Constitution, the Executive Committee has called elections for national representatives in a number of countries. There is a requirement for a national representative elected for each nation represented by at least two individual members. The term of office for national representatives is four years; however they may be elected for a second term of office of four years.
